- I hereby warrant that the named parent or legally appointed guardian is responsible for the safety and wellbeing of the named child in the making of a rail safety entry (e.g. staying away from the rail network and trains) and when accompanying the child on the TranzAlpine trip.
- I understand it is my responsibility to book TranzAlpine seats in the timeframe provided by LEARNZ on receiving the tickets and if I want to book other seats it is also my responsibility to organise and pay for these.
